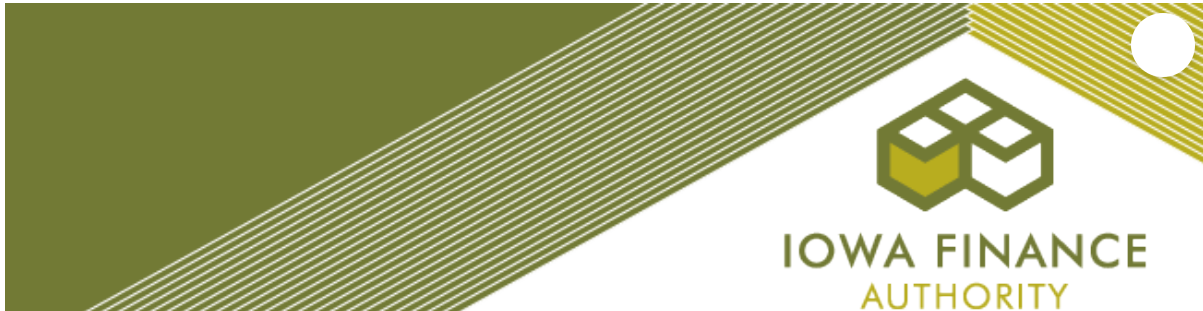

The Iowa Finance Authority's updated income and purchase price limits are **effective Wednesday, June 1, 2022.**

The purchase prices for both FirstHome and Homes for Iowans have increased.
