IOWA TRADITIONAL ARTS APPRENTICESHIP GRANT

Fiscal Year 2026

BACKGROUND

The Iowa Traditional Arts Apprenticeship Grant is administered by the Iowa Arts Council, which exists within the Iowa Economic Development Authority (IEDA). Through the program, IEDA provides support to teams of mentor artists and apprentices who are committed to sustaining artistic traditions and cultural heritage. The program helps to ensure the continuation of cultural practices throughout Iowa.

The program is funded through an appropriation by the Iowa Legislature to IEDA and a grant by the National Endowment for the Arts, a federal agency. Applicants must comply with federal requirements, including but not limited to <u>2 CFR Part 200</u>. Operating and grant policies and definitions set out at 261 Iowa Administrative Code Chapter <u>305</u> and rules pertaining to organization and operation of the Iowa Arts Council found at 261 Iowa Administrative Code Chapter <u>304</u> apply to the program. Additional eligibility requirements and priorities are set out in these guidelines published by IEDA.

QUESTIONS

TIMELINE

April 22, 2025 | Fiscal Year 2026 Application Deadline

The deadline to submit an online application is 11:59 p.m. on April 22, 2025, for the funding period July 1, 2025 - June 30, 2026.

Funding Notification

Typically, applicants are notified of funding decisions within eight weeks after the application is submitted.

July 1, 2025 – June 30, 2026 | Eligible Funding Period

The eligible funding period is July 1, 2025 – June 30, 2026. All expenses must be incurred and apprenticeship activities must be completed within the eligible funding period.

August 1, 2026 | Final Report Deadline

Grant recipients are required to complete a final report by August 1, 2026.

GRANT AMOUNTS AND DISBURSEMENT

The mentor artist will receive a \$3,000 grant and the apprentice will receive a \$1,000 grant to support their work together over the course of the year. An additional \$1,000 can be requested to cover travel, supply/material costs, and expenses related to the public event. Grantees will receive 50% of the award up front and 50% upon completion of the apprenticeship year. Recipients will need to complete a final report at the end of the eligible funding period outlining how the grant funds were spent. Any unspent grant funds will need to be returned to IEDA within 30 days after the final report deadline.

APPLICATION REQUIREMENTS

Eligible Applicants

Eligible mentorship teams must consist of the following requirements.

- Individual mentor artist, who is formally or informally recognized for excellence in their artistic traditions and communities
- Individual apprentice artist, who has some previous training in the folk and traditional artform

Additionally, eligible applicants must meet all the following requirements. Individuals who do not meet all the requirements are not eligible for funding.

- U.S. citizen or possessing a Permanent Resident Card (i.e. "Green Card") or in the process of obtaining a Permanent Resident Card, who is a full-time Iowa resident domiciled in Iowa or maintaining a permanent place of abode in Iowa. For purposes of these Guidelines, the terms "domiciled" and "permanent place of abode" are defined in <u>701 Iowa Administrative Code</u> <u>38.17</u>
- 18 years of age or older

Ineligible Applicants

Ineligible applicants include the following:

- Individuals enrolled in any type of undergraduate degree granting program at the time of application
- Artist groups, collaboratives and collectives
- For-profit business

• IEDA grantees that are not in compliance with reporting or other requirements, or who have been placed on IEDA's funding moratorium list

PROGRAM EXPECTATIONS

Mentor artists and apprentices work together over the course of the program year (July 2025 – June 2026) to teach and learn skills related to a folk and traditional artform to preserve and cultivate it for future generations. Folk and Traditional Arts may include music, dance, visual arts, language practices, traditional skills, foodways, occupational arts, and storytelling. Traditionally these artforms are not self-taught or learned in a formal educational setting. They are learned through mentorship, observation, and practice.

Applicants commit to spending at least 100 hours of one-on-one time together during the program year. There will need to be a public event at the end of the apprenticeship year providing the apprentice an opportunity to demonstrate their work.

BUDGET REQUIREMENTS

Eligible Grant Expenses

Iowa Traditional Arts Apprenticeship Grants support expenses that are essential to the apprenticeship. The grant must be dedicated to eligible one-time, direct expenses that are legitimate parts of the proposed project. Costs must be incurred and expended within the eligible funding period. Expenses should be based on competitive, current market pricing.

Eligible grant expenses include direct project costs, such as:

- Artist fees (the mentor artist and apprentice artist's time working on the apprenticeship)
- Domestic travel (e.g. mileage, per diem, and accommodation following the State of Iowa <u>in-state</u> employee travel rates, as necessary for participation in the apprenticeship)
- Expenses related to the Public Event (e.g. access accommodations, marketing, rentals)
- Materials and supplies for Apprenticeship (e.g. paint, costumes, food items)

FUNDING PRIORITIES

Priority is given to traditional art forms with few practitioners left in the local community and applicants that represent the spectrum of cultural communities across the state.

REVIEW PROCESS

Eligibility Review

Submitted applications are reviewed by staff for completion, eligibility and adherence to published guidelines. Applications are reviewed as submitted, provided that IEDA may contact applicants if any additional information is required. New application information or subsequent application clarification submitted after a program deadline is not considered unless requested by an IEDA program manager.

Staff will also review an applicant's record of compliance and good standing with the Iowa Arts Council, IEDA, other state agencies, including but not limited to the Iowa Department of Revenue, and federal government agencies or departments. Applications or applicants determined by staff to be ineligible or incomplete will not move forward to panel review. A determination as to eligibility or completeness is final agency action.

Competitive Panel Review

Applications by eligible applicants that are complete and adhere to program requirements will be referred for a competitive review by a panel of professionals with expertise related to the purpose of the grant program. Applications will be scored and ranked based on the published scoring rubric. Recommendations for consideration and approval are submitted to the IEDA Director.

Decision Notification

Applicants are typically notified of funding decisions, including decisions to decline to fund applications, within eight weeks after the application deadline. Applicants are encouraged to refrain from contacting staff for application status updates during the funding decision process.

APPLICATION SUBMISSION

Applicants must submit applications via the Iowa Arts Council's SlideRoom, an online application portal. Applications will not be accepted in any other format. Late, incomplete or ineligible applications will not be accepted. Applicants can access the current online application requirements at <u>iowaartscouncil.slideroom.com</u>. Applicants must create a login to view the full application requirements for the program. Applicants can visit <u>help.liaisonedu.com</u> for assistance related to the online submission.

APPLICATION

Application Questions and Scoring Rubric

The Iowa Traditional Arts Apprenticeship Grant scoring rubric will be used to evaluate applications. Each section has criteria and corresponding point values to ensure an unbiased review process. The rubric is on a scale of 45 points. The following application questions are provided for reference only. Applicants must review and complete application requirements in the SlideRoom portal.

Mentor Artist Profile

Describe the traditional artform that will be taught.

Provide the mentor artist's background and experiences in that traditional artform, including:

- How long the mentor artist has been practicing the traditional artform
- How, when, where the mentor artist learned the traditional artform
- Who influenced the mentor artist in the traditional artform

• The role and importance of the traditional artform in their cultural community.

Artistic Work Samples

Submit 5-10 artistic work samples. Include samples from both the mentor artist and apprentice. Artistic work samples should demonstrate the quality of the traditional artform highlighted in the application or the quality of the applicant's past work as it relates to the apprenticeship. Artistic work samples should be recent, high quality, and must represent an artistic work or performance. It can also include images or videos of past events or classes. Artistic work samples DO NOT include bios, testimonials, news articles or marketing material such as brochures, fliers or posters.

- Provide 5-10 items.
- Video and audio files should not exceed three minutes each.
- PDF files should not exceed five pages each.
- Panelists will not be required to view more than five pages of a document or more than three minutes of an audio or video file.

Include a description with each sample, including:

- Title of the sample
- Date of the work or activity
- Names of artist(s) featured if applicable
- Relevance of the work sample to the proposed apprenticeship
- If an audio or video sample is longer than three minutes, indicate the three-minute segment the panel should view.
