I. ADMINISTRATION

A. ROLL CALL

The meeting of the Board of the Iowa Agricultural Development Division (IADD) of the Iowa Finance Authority (IFA) was called to order by Chair McLain on October 23, 2024 at 2:30 p.m. A quorum was established with the following Board Members present; McLain, Townsley, Boyle, Masker-King and Ungs.

B. APPROVE MINUTES OF SEPTEMBER 26, 2024 BOARD MEETING

MOTION

On a motion by Ms. Townsley and a second by Mr. Boyle, the Board unanimously approved the minutes of the September 26, 2024 IADD Board meeting.

C. REVIEW SEPTEMBER 2024 FINANCIAL STATEMENT

Becky Wu presented the September 2024 financials. For FY25 year-to-date, IADD's operating income was \$136,000, its operating expense was \$81,000, and the net operating income was \$54,000.

Tammy Nebola shared that the loan participation application P0330 was withdrawn.

IV. BEGINNING FARMER LOAN PROGRAM APPLICATIONS

A. REVIEW AND APPROVE BFLP LOAN APPLICATIONS

Tammy Nebola introduced the following applications for Beginning Farmer loans:

<u>AG 24-047</u> – Ben Kuehnast applied for a BFLP loan of \$333,438 to assist with the purchase of approximately 49 acres of agricultural land in Humboldt County. The lender is Northwest Bank in Fort Dodge, IA. The lender's loan terms are: 25 year loan term and 4.90% variable (equal to Wall Street Journal Prime) interest rate.

<u>AG 24-048</u> – Emmitt Joe and Nicole Wheatley applied for a BFLP loan of \$624,030 to assist with the purchase of approximately 142 acres of agricultural land in Adair County. The lender is Union State Bank in Greenfield, IA. The lender's loan terms are: 30 year loan term and 5.65% variable (2.35% below Wall Street Journal Prime Rate) interest rate.

<u>AG 24-049</u> – Jason A. Volker applied for a BFLP loan of \$250,000 to assist with the purchase of approximately 12 acres of agricultural land with house and out-buildings including a dairy site in Fayette County. The lender is Citizens Savings Bank in Spillville, IA. The lender's loan terms are: 30 year loan term and 6.50% variable (equal to Citizens Savings Bank's 5-year tax-exempt rate index) interest rate.

MOTION

On a motion by Ms. Townsley and a second by Mr. Boyle, the Board unanimously approved the BFLP applications.

B. PUBLIC HEARING ON ISSUANCE OF BONDS FOR BEGINNING FARMER LOANS

A public hearing was held by the IADD Board on October 23, 2024 at 2:44 p.m. regarding issuance of bonds for the Beginning Farmer Loan Program. No members of the public attended the hearing and no comments were received. The public hearing was closed at 2:45 p.m.

C. APPROVE BFLP BOND DOCUMENTS

MOTION

On a motion by Mr. Boyle and a second by Mr. Ungs, the Board unanimously recommended that the Iowa Finance Authority Board approve the BFLP Bond documents.

V. BEGINNING FARMER TAX CREDIT PROGRAM (BFTC) APPLICATIONS

Nicki Howell presented 11 new BFTC applications for approval with an estimated aggregate total of \$167,171. Of the 11 applications received, 9 are cash rent and two are crop share.

MOTION

On a motion by Mr. Boyle and a second by Ms. Townsley, the Board unanimously recommended that the Iowa Finance Authority Board approve the applications for BFTC tax credits as presented.

VI. MARKETING UPDATE

IADD staff reported on recent and upcoming events where they marketed IFA's programs to assist farmers.

VII. OTHER BUSINESS

A. IFA BOARD MEETING UPDATE

McLain presented the agenda from the October 2, 2024 IFA Board Meeting. Aaron Smith gave a brief update of the meeting.
