- 4. I acknowledge that I am obligated to notify Iowa Title Guaranty (ITG) of any unexpected PFA alerts I receive concerning the Property. Any such alerts must be forwarded to <a href="ITGClaims@iowafinance.com">ITGClaims@iowafinance.com</a> as soon as I am aware of them.
- 5. I acknowledge that I am further obligated to notify ITG of any information I obtain that indicates a potentially fraudulent deed or mortgage related to the Property, regardless of whether such information is or is not obtained via a PFA service.
  - NOTE: ITG is not a law enforcement agency, and notifying ITG of a fraud alert or potentially fraudulent activity is not a substitute for notifying local law enforcement, federal law enforcement, or your attorney, if appropriate.
- 6. I acknowledge that, as of the date of this Affidavit, I have no knowledge of any attempts to obtain and/or file a forged deed and/or mortgage related to the Property.
- 7. I acknowledge that failure to enroll in an available PFA service, failure to immediately notify ITG of any PFA alert, and/or failure to notify ITG of any other potentially fraudulent activity may result in a denial of any claim I may make under the Endorsement.
- 8. I, the Proposed Titleholder, have disclosed all matters based on information known or reasonably available to me and certify that all matters stated herein are true and accurate. I make the above statements for the purpose of inducing Iowa Title Guaranty to issue an Owner's Certificate and the requested Endorsement with respect to the Property. I hereby indemnify and hold harmless Iowa Title Guaranty against any and all loss, costs, damages, and expenses of every kind, including, but not limited to, attorney's fees, incurred by Iowa Title Guaranty by reason of its reliance on the statements made herein.
