Motion by Thomas Treharne and seconded by James Halverson to find that the land included without the consent of the owners under the provisions of Iowa Code §368.7(1) comprises of not more than 20% of the territory proposed to be annexed. Motion with a roll call vote: Yes: Dennis Plautz, James Halverson, Colleen Frein, Thomas Treharne; No: None; Absent: None. MOTION PASSED.

Motion by Thomas Treharne and seconded by James Halverson to approve the annexation as it conforms with the City's Comprehensive Plan, provides more uniform boundaries and the City has the ability to provide utilities & other city services. Motion with a roll call vote: Yes: Dennis Plautz, James Halverson, Colleen Frein, Thomas Treharne; No: None; Absent: None. MOTION PASSED.
